### WDAA Membership Statement

To be eligible to participate and/or compete as an exhibitor, owner, lessee, agent, coach, or trainer in any Western Dressage class or at any Federation Western Dressage Licensed Competition persons must be active members of WDAA or pay a non-member fee equal to the price of an annual membership for each competition. Exception: WDAA membership or non-member fee is not required at a Lite Licensed competition. Lessees are considered owners in connection with this membership requirement. In the event of an entry under multiple ownership, only one owner need be a Member or pay a non-member fee. The competition is responsible for listing either the active member or the owner that paid the non-member fee in the results. The competitions will be responsible for forwarding a list of the names of individuals who pay non-member fees at the competition to WDAA with the post competition report. Payment of non-member fees for the purpose of competing does not entitle the individual to any privileges of the WDAA membership.

### AHA ENTRY AGREEMENT

I have read the rules concerning competitions as printed in the Arabian Horse Association (AHA) Handbook / Directory and Competition Prize List and agree to be bound by and subject to those Rules.

**AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION** This document waives very important legal rights. Read it carefully before signing.

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:

**I AGREE** that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.**

**I AGREE** as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.

**I AGREE** for myself, my heirs, executors, administrators, successors and assigns to release AHA, the Competition, the facilities leased by the Competition and the owner(s) of the facilities, and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and all claims for damage, loss, or injury to myself, other persons, horses or other property belonging to me to the fullest extent permitted by law that arises out of or relates in any way to the Competition and my participation in the Competition INCLUDING, BUT NOT LIMITED TO, DAMAGES, LOSS, OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLIGENCE OF OTHER ENTRANTS, THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defects in the premises.

Those likenesses shall not be used to advertise a product and they may not be used in such a way which implies endorsement of any company, product, product category or service. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

**By signing below** as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this AHA Assumption of Risk, Release and Indemnification personally and on behalf of the child.

This AHA Assumption of Risk, Release and Indemnification is governed by the Laws of the State of Colorado and is intended to be interpreted as broadly as possible. For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

**A. RULES AND REGULATIONS:** I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at [www.usef.org](http://www.usef.org), as amended from time to time.

**B. ACKNOWLEDGMENT OF RISK:** I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves inherent risks and dangers. #### **Academy Class Specifications**

The AHA Academy Riding division is designed to welcome new riders into the Arabian horse show world by offering a positive, low-pressure introduction to competition. Open to beginning riders and any breed of horse, Academy classes provide an opportunity to build skills, gain confidence, and experience the joy of showing. Sections may be added to allow multiple riders to show the same horse. **Sections will be assigned at the riding instructor's request.**

**RIDERS:** Are encouraged to be in a professionally operated lesson program. (not required). First Year Academy Exhibitors are eligible for a FREE AHA Youth Membership. Riding saddle seat suits, hunt coats and western chaps are NOT allowed. Riding pants, jodhpurs, breeches or colored jeans are considered appropriate. A neatly fitted shirt or top is suggested. A riding helmet is MANDATORY for riders 18 years of age and under and suggested for all ages. Appropriate footwear with a small heel is MANDATORY. Riders are NOT allowed to cross enter into any non-Academy riding classes and are ineligible to compete in Academy classes once they have shown in a full riding suit or in a non-Academy type show.

**HORSES & EQUIPMENT:** Horses should be regularly used as lesson horses but it is not mandatory. Any breed of horse is allowed and should display good manners and a quiet disposition. Any horse and rider that is deemed unsafe or is not abiding by these rules may be eliminated by the horse show management or judge. A cut-back saddle for saddle seat, western saddle for stock seat, hunt saddle for hunt seat, and dressage saddle for dressage seat are to be used. Work bridles and bits, including snaffles are allowed, and running martingales are permitted and encouraged. However, the tie down martingales is NOT allowed. Riders may not cross enter between the Leadline, Walk/Trot, or the Walk/Trot/Canter classes. Show grooming is permitted, but not necessary as HORSES ARE NOT TO BE JUDGED.

**JUDGING:** All Academy classes are to be judged on the ability of the rider to control and show their horse to its best advantage and upon the riding skills of the rider. Each class should be judged on the rider's basic equitation and horsemanship skills, identify correct diagonals and leads promptly, and to control their horses rate in a consistent manner. Riders should convey the impression of good posture, balance, and effective control while commanding proper speed of gaits and show ring placement. Headers are allowed in the line up in all walk/trot classes. HORSES ARE NOT TO BE JUDGED, only the rider's ability to control themselves and their horses while presenting themselves to their advantage. Horsemanship is meant to differ from the Equitation class in that it is judged more on the rider's ability to display their horse to its best advantage. Classes may be split at the discretion of show management. Entries into these classes must follow written Show Premium rules but are NOT AHA or USEF sanctioned classes.

**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

#### Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### Memberships Defined

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

#### How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

## **RULES AND REGULATIONS**

Photostatic copies of your Amateur Certification, USEF Membership/Competition Card, AHA Membership/Competition Card and registration papers for each horse entered **MUST** accompany your entries. USDF card is not required for Dressage entries. However, a WDAA membership is required for Western Dressage entries. Health certificates and vaccination documentation will be required for all horses entering the show grounds. See Health Certificates section.

**EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.**

Show management will be charged with the responsibility of enforcing all USEF and AHA rules. Special emphasis will be placed on the rules pertaining to the retention of natural action; excessive hoof length, weighted shoes or action brought about by these or similar artificial appliances. The use of chains, rollers or similar devices on the show grounds during or before a show are prohibited and the show committee shall bar violators from further participation for the remainder of the show and they shall forfeit all entry fees and winnings for the entire show.

Show management retains the right to request measurement of hoofs and inspection of pads of any or all horses in any or all classes.

**KENTUCKY RIDERS AND BREEDERS SOCIETY, INDIANA ARABIAN HORSE CLUB AND WORLD EQUESTRIAN CENTER** accept no responsibility for loss or damage to any property or equipment, or for any damages to any animals on exhibition at these shows.

**ADMISSION TO THE RING:** No persons will be allowed in the ring except participants in class, judge, ringmaster, assistants and show photographer. Attendants will be allowed only after being called by the Judge or Ringmaster. **EVERYONE'S USEF SAFE SPORT TRAINING MUST BE COMPLETED OR THEY WILL BE DENIED ENTRY TO THE RING.**

**ATTENTION HANDLERS:** Cruelty to or the abuse of a horse by any person at a recognized competition is forbidden. Excessive use of a whip on any horse in a stall, runway, schooling arena, competition ring or elsewhere on the competition grounds before or during a competition by any person constitutes a violation and renders the offender subject to penalty. Halter horses brought into the ring showing signs of whip marks will be penalized. Excessive use of the whip in the show ring will be penalized.

**BAD CHECKS & CREDIT CARD:** All checks and credit cards sent with entries will be cashed upon receipt. **Non-Negotiable check & credit card fees:** There will be a **\$100.00** charge for all returned checks and credit cards per occurrence. Parties who do not respond with full payment including \$100 fee within 7 days of being notified of such incident will be reported to AHA and USEF.

**BEDDING:** No bedding will be provided with a stall. All shavings must be purchased through the supplier on the show grounds and should be pre-ordered before the show. If shavings are needed during the show the exhibitor must go to the show office to place an order. All bedding purchased will be billed through the show office. No animals can be stalled without bedding. Straw is not permitted.

**CALL FOR CLASSES:** Classes will be called promptly at the times announced. First call occurs when horses two classes ahead enter the ring. Second call occurs when the preceding class enters the ring, Third call will be made when ribbons are being awarded in the preceding class. To prevent delays, the two-minute rule after the first horse is entered in the ring will be enforced. We appreciate your cooperation and request that the paddock managers be notified of any expected delays for tack changes. All delays must be approved by the show committee.

**CAMPERS:** All campers parked on the show grounds must pay RV fee listed in this prize list to The Medallion. Camper parking passes may be obtained from the show secretary and must be purchased prior to parking. Camping passes must be always displayed on the camper in plain sight. All campers that are found not to have purchased a parking pass will be subject to a \$100.00 fine and towed at the owner's expense.

**CANCELLATION OF CLASSES:** The Show Committee reserves the right to cancel or combine any classes or make any scheduling change for the betterment of the show.

**CHAMPIONSHIP CLASSES:** Supreme Halter Championships horses placing first in qualifying classes are eligible. To be eligible to show in a Performance Championship class, a horse must be properly entered, shown and judged in a qualifying class as specified.

**DISQUALIFICATIONS:** If any Exhibitor has made any false statements regarding an animal exhibited, or if any Exhibitor shall attempt to interfere with the Judges in the performance of their duties, he or she shall be excluded from exhibiting. Any act of discourtesy or disobedience to the official on the part of the owner, rider, exhibitor, groom or driver will disqualify the horse from being judged. The Show Management reserves the right to remove any of the previous mentioned, (owner, rider, etc.), without being liable to compensation or damages.

**DOGS:** Dogs and other pets must be on a leash at all times while on the show grounds. A fine of up to \$100 will be imposed for any loose dogs, per occurrence. All fines will be donated to the local Clinton County ASPCA. Management reserves the right to impound loose dogs and/or summon Animal Control at the owner's expense to have the animal removed from the grounds. Do not lead a dog while mounted. Please do not tie dogs in aisles, they are a danger to passing horses and people.

**DRESS:** It is the tradition of the show ring that riders and drivers be correctly attired for the class in question, that attendants (headers) be neatly dressed, and horse properly presented. The show committee will bar any entry or person from entering the ring if not suitably presented to appear before an audience.

**FIRE MARSHALL'S REGULATION:** All aisles will be open at all times. There will be no closing off of aisles for any reason. Decorations cannot extend out more than 18 inches into the main aisles. No stall roof is allowed to be covered with any type of material.

**FOOD and SHOWERS:** Food will be available on the grounds. Showers are available on the grounds.

**HEADERS:** Permitted in all driving classes and walk/trot classes, but MUST be properly attired.

**HEALTH CERTIFICATES:** Copy of Negative Coggins test within 12 months required for all horses, Health Certificates within 30 days required for out of state horses. At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables (USEF GR845). Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. It is recommended that vaccines are administered by or under the direction of a veterinarian.

**JUDGES:** In the event due to illness or failure of a judge to attend the show or to perform their duties due to circumstances beyond their control, the show committee reserves the right to substitute a judge for the one that is officially designated in the prize list according to the USEF rules GR1211.

**JUNIOR EXHIBITORS:** Junior Exhibitor classes are limited to riders who have not yet reached their 19<sup>th</sup> birthday as of December 1, of the preceding year.

**NATIONAL SHOW HORSES:** All exhibitors must supply the show with a copy of the official NSHR Certificate of registration or confirmation letter before the horse is allowed to show in a NSH class. Registrations can be completed in the show office with a copy of the horse's Half-Arabian registration. In the event an unregistered horse enters into a NSH class, the show management will report the violation to USEF in accordance with applicable rules. At least one owner MUST be a member of the National Show Horse Registry to compete in National Show Horse classes at local shows. Membership applications will be available in the show office.

**OFFICE CHECK-OUT and BILL DISPUTES:** Everyone, including trainers, must come to the office to check out and settle their show bill. This must be done as soon as possible after no further charges will be applied to the bill. One hour after the last class any bills remaining will have their check or credit card filled out for the recorded balance owed at that time. and any disputes on accounts not checked out in person will be forfeited. **BILL DISPUTES:** Any disputes regarding an exhibitor's or trainer's show bill (invoice) that was checked out during the show must be reported to the show secretary within 1 week (7 calendar days) of the close of the show,

**PRIZE MONEY:** There will be no prize money awarded.

**PROTESTS:** All protests will be in accordance with USEF rules. No exhibitors shall approach a Judge unless he first obtains permission from the Show Committee or Steward. Protests may be made to the Show Committee or Steward by an exhibitor, an agent, a trainer, or the parent of a Junior Exhibitor for any violation of the USEF rules. All protests must

be in writing signed by the protester, addressed to the Show Secretary, accompanied by the appropriate fees, within 48 hours of the alleged violations. This deposit will be returned in the event the protest is allowed. According to USEF Bylaws.

**REFUNDS:** Refunds can be requested prior to pre-entry deadline. After pre-entry closing date only class entry fees will be refunded with Certified Vets medical report verifying medical inability of the horse to show and a written refund request by the horses recorded owner, which must be delivered to the show manager by the end of the last class of the show. Office charges are not refundable. All refunds are at the discretion of the show committee.

**SAFE SPORT STATEMENT:** Any competition with the start date of September 1, 2020 and later will be required to include the following Safe Sport statement in the Rules and Regulation section of the prize list: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org).

**SHARPS CONTAINERS:** At least one Sharps container per fifty occupied stalls has been provided for the disposal of needles and other disposable sharp instruments in convenient locations within the barns. Competition Management may fine any individuals including trainers, owners, exhibitors or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments (per USEF GR1210.4).

**SHOW ARENAS:**

R&L Arena (Main Show Arena) is approximately 130 feet by 615 feet and will be divided into a warm up area and a Show Ring of approximately 120 feet by 200 feet.

Roberts Arena (Dressage and Sports Horse in Hand Arena) is approximately 110 feet by 266 feet.

Both arenas have premium synthetic footing and LED lighting. Lunging is permitted only in R&L Arena.

**SMOKING:** No person will be permitted to smoke in any building on the show grounds at any time per Ohio State Law,

**STABLING:** All stalls will be reserved as paid for - No stall reservations without payment. Stabling is either in permanent stalls or temporary stalls with doors. Stalls are available on a first come first serve basis after show sponsors are stalled. There will be no refunds for stalls. No horses shall be stalled without bedding. No straw bedding is permitted. All manure must go in the provided receptacles. Manure is not to be put in garbage cans or left on the blacktop. To do so will result in additional billing for the cost of cleanup.

**TACK CHANGES:** Normal Tack Changes will be 3 minutes followed by a 2-minute gate for a total of 5 minutes. A normal Tack Change must be requested of the Paddock Master at least 3 classes in advance. Should any horse or rider have back-to-back classes and additional time be required for this change, the Show Manager must be notified of this fact prior to the start of the session in which this extended Tack Change is requested.

**USEF CERTIFICATION & AMATEUR CLASSES:** Every person who has reached his 18<sup>th</sup> birthday and competes in classes for amateurs under USEF rules must possess current amateur certification issued by USEF This certification must be available for inspection or the competitor must have lodged with the Show Secretary at least one hour prior to such class, an application for such certification provided by the USEF. Individuals joining USEF on the day of the show must fill out a current USEF membership application.

**ABSOLUTELY NO ALCOHOLIC BEVERAGES ARE PERMITTED AT WORLD EQUEDRIAN CENTER AND GROUNDS. VIOLATORS WILL BE PROSECUTED.**

**Ground Rules**

- 1.) No parking in any restricted area. All vehicles and trailers must be parked in:
  - The designated parking lot(s).
  - Camper rental area when you rent such a space.
  - Cars only are to be parked in front of the main arenas. This parking is restricted against trailer parking.
- 2.) Overnight, all horses are to be in a stall. When rental stalls are not available, horses are to be kept in a trailer during the night. Absolutely no horse may be tied to any fence at any time.
- 3.) No motorized vehicles or bicycles are allowed on any porch or sidewalk at any time.



## Rules and Prohibited Items

### Motorized Vehicles on Property

- 1 You must have a valid driver's license to operate any motorized vehicle while on WEC property.
- 2 No motorized vehicles will be permitted to operate on SR 730.
- 3 Operating motorized vehicles on property in a reckless or unsafe manner is prohibited.

### Parking

- 1 Parking is prohibited in front of manure pits and/or anywhere signs prohibit.
- 2 Trailers are prohibited from blocking multiple parking spaces and must be parked in designated trailers parking locations.
- 3 Trailers are prohibited from parking and/or driving behind the RI Arena and barns E, F, G, H, I, J, or K.

### Camping and RV Sites

- 1 The dumping of grey and/or black water tanks onto WEC property is prohibited unless it is into a designated dump station.
- 2 Using WEC electricity without prior registration is prohibited.

### Dogs

- 1 Dogs must be kept on a leash at all times while on property.
- 2 Any dog that is deemed aggressive by WEC staff or security will be asked to be removed from property or put away in the owner's residence.

### Barns / Arenas

- 1 There is NO SMOKING inside any building on WEC property.
- 2 All medical waste (sharps) must be disposed of in the proper containers provided.
- 3 Any item brought into a barn that is deemed to be a fire hazard by WEC staff or security is prohibited.

- *Violation of any of the above may result in a fine and/or eviction from the property.*
- *These rules are not all inclusive.*
- *The World Equestrian Center is privately owned and we reserve the right to enforce these rules as needed.*

## Security Tips

- ▶ Report suspicious activity to WEC security.
- ▶ Be aware of your surroundings.
- ▶ Keep tack stalls and trunks locked when not in use.
- ▶ Do not leave valuables, such as cell phones and purses, unattended in barns.
- ▶ Keep your vehicles locked and always store valuables out of sight.

## Horse Evacuation / Emergency

- ▶ Place halter and lead rope outside each stall.
- ▶ Post after hours emergency contact info for each horse.
- ▶ Be familiar with evacuation routes and tornado shelters posted in each barn.

## Fire Prevention

- ▶ There is a ZERO TOLERANCE FOR SMOKING IN BARNs - \$2,000 FINE. (There is no smoking in the cabins/Home Away from Home)
- ▶ Keep fire extinguishers mounted to walls.
- ▶ Keep your area clean.
- ▶ Do not hang extension cords with nails.
- ▶ Do not block fire exits.
- ▶ Disconnect all electrical devices when not in use.
- ▶ No open flames / hot plates.
- ▶ Report any fire related issue to WEC security ASAP.

## AHA and USEF Statements

### AHA Membership Statement:

EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR.

WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP.

SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS.

EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS.

EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)

### USEF Membership Statement:

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

### USEF Motorized Vehicle Statement:

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

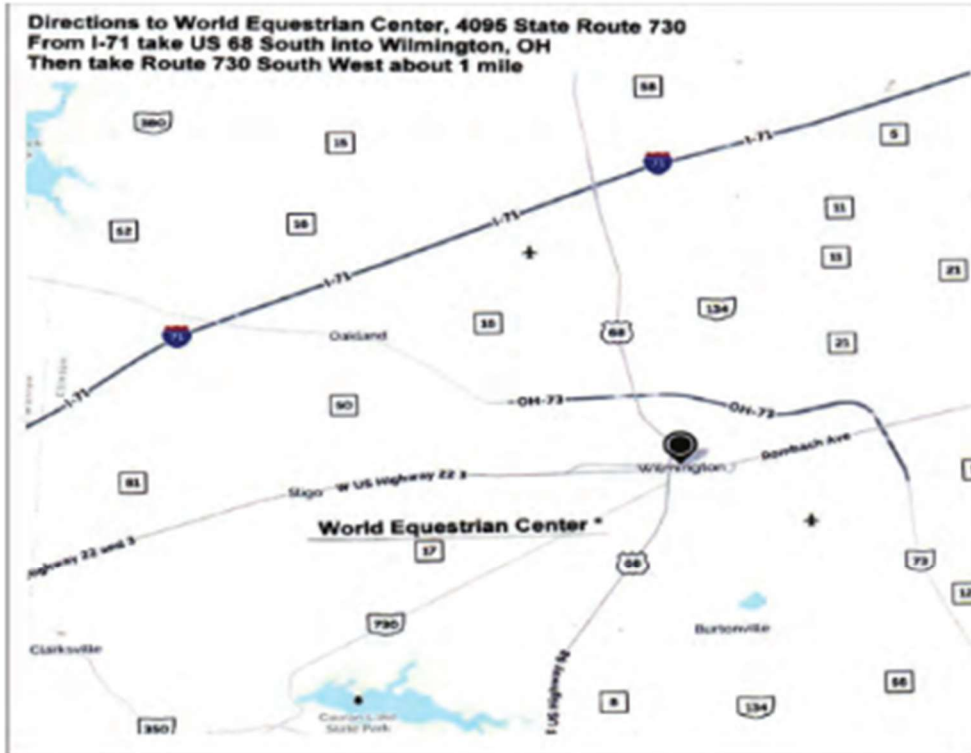
